

Anton Michelsen (1809-1877) founded the A. Michelsen Company in Copenhagen in 1841 and was soon receiving commissions from the Royal Family. After his father's death, Anton's son Carl took over the business, making it the leading gold and silversmith company in Denmark. By 1972 the company was brought by the Royal Copenhagen Porcelain Manufactory and merged with the firm **Georg Jensen Silversmiths Ltd.**



In 1970 Mikkelsen established his own company, A/M Design, before returning to Jensen in 1983 as artistic director.

PUIG DORIA is a Spanish Jewel House, founded in 1948 by José Maria Puig Doria who set up his first jewellery workshop on Calle Provenza, Barcelona. By 1958, he bought the ground floor of the premises, where he exhibited and sold his designs. By 1969, the company had expanded considerably and relocated to its current premises, Avenida Diagonal 612. In 1976, with business continuing to grow, a new store was opened in Geneva and in 1984 in Japan, with three years later, a flagship store in the very centre of Barcelona and another in Valencia. José received numerous awards and accolades during his long career, the highlight being in 2002 when he was presented the Creu de Sant Jordi Award, one of the highest civil distinctions awarded in Catalonia. He died in 2006 and the business continues under the management of the next generation of the family, Cristina and Beth Puig Doria together with José's son, José Maria Puig Doria.

Barbara Bertagnolli

IsabelleFa

In 1955, Emil Mössner (1922-2002), a German goldsmith and silversmith, established the 'Emil Mössner Goldwarenfabrik' in his hometown of Eisingen, near Pforzheim, initially producing mostly gold chains. Over the years, the business grew from its modest beginnings, and, as was common in Pforzheim, produced exclusively for the wholesale trade. In the mid 1980s, the founder's son, master goldsmith Hans-Georg Mössner, took over the management of the company. His wife Isabelle Fagnoul from Malmedy, Belgium, joined the company in 1987. The couple had met at the goldsmith's school in Pforzheim. Inspired by their love of the traditional crafts practised at the manufactory in Eisingen, Isabelle and Hans-Georg Mössner continued these methods of craftsmanship and production and in 1987, together established 'IsabelleFa GmbH - Fabrikation feiner Goldwaren' with the new brand name IsabelleFa, inspired by her maiden name. Still concentrating on the production of gold chains and bracelets, the newly formed company introduced innovative designs which were to become iconic, in particular the bold 'navette' chain. IsabelleFa has become known for her collections of minimalist and large format purist designs, using highly polished and matte surfaces.



en Duong is a modern designer of Vietnamese heritage, her early years being spent in Wales. She studied at the Sir John Cass School of Art in London, graduating in 1995. She established YEN Jewellery the following year, working from her studios in Bloomsbury, her designs showing her fascination with the structural elements of jewellery, and incorporating movement and fluidity, with a highly tactile quality. Previous exhibitions of her work include those held at The Goldsmiths' Company and the Crafts Council, and she has worked with Liberty of London, Selfridges and Harvey Nichols.





Dagobert Peche (1887-1923) was an Austrian artist and jewellery designer. Having initially trained as an architect, Peche joined the Wiener Werkstätte in 1915. He was a prolific designer in all media and went on to produce the most jewellery designs for the firm, second only to Josef Hoffmann. Peche's designs are noted for their sculptural qualities, often based on mythological themes or featuring an abundance of foliage and floral motifs, "threatening to spill out of their allotted space". During the war, material restrictions inspired the sculptor and master craftsman Friedrich Nerold to render many of Peche's designs in ivory. Many jewels produced by the Wiener Werkstätte during this time also feature collet-set cabochon gemstones, as seen here, not only to further the sculptural qualities of the piece but also enhance the colour palette used.

De Vroomen

Born in Holland during the Second World War, Leo de Vroomen was the youngest of eight siblings. His family were tulip farmers but from an early age Leo dreamed of a different life. Following his apprenticeship in The Hague and qualifying as a Master Goldsmith in Switzerland, he came to London in 1965. It was whilst lecturing at the Central School of Art and Design that he met his future wife - the artist and designer Ginnie. They married and in 1976 together founded De Vroomen Design Ltd. The company rapidly expanded and the distinctive De Vroomen style gained international reputation. During these years, Ginnie's painting became increasingly important and in 1997, she had her first solo show in Chelsea.

De Vroomen went on to be the winners of the coveted De Beers Diamonds International Award in 1974, wining a second award in 1986. In 1991, the Goldsmiths' Hall held a retrospective exhibition of their work, marking 20 years of the partnership between Leo and Ginnie. A second exhibition at Goldsmiths' Hall took place in the summer of 2017, to celebrate 50 years of De Vroomen jewellery, the jewellery exhibited to the backdrop of Ginnie's exquisite paintings.

Over the years, De Vroomen have evolved their distinctive style, using strong sculptural forms modelled in gold and set with gemstones, enamel and pearls, their minimal use of diamonds showcasing the bold coloured stones, cloisonné and champlevé enamels.

Born 1646, Lady Frances Annesley was the daughter of 1st Earl of Anglesey and Lady Elizabeth Altham, Countess of Anglesey. Her first marriage was to Francis Wyndham but when widowed in 1688, she married Sir John Thompson, 1st Baron Haversham (1648-1710), an English politician, with whom she had at least eleven children. Thompson was the first surviving son of Maurice Thompson of St Andrew, Eastcheap, City of London and Haversham, who at one time is said to have obtained a monopoly of the Virginia tobacco trade. Sir John was created a Baronet of Haversham in the County of Buckingham in 1673, and later returned to Parliament where he held a seat for Gatton until 1696, and was raised to the peerage as Baron Haversham. Between 1699 and 1701, he was Lord of the Admiralty. Lady Frances Haversham died in March 1705. Her son Maurice succeeded as 2nd Baron Haversham after his father's death in November 1710. He entered the House of Lords, between 1717 and 1718 he was a Treasurer of Excise. He married twice, with at least two daughters from his first marriage, but having no sons, after his death in April 1745, his titles died with him.

Approximately 160 scholars, scientists and artists and in the discovery of the Rosetta accompanied Napoleon on an expedition that culminated in the discovery of the Rosetta Stone in 1799. The subsequent publication of various illustrated journals, namely the Description de l'Égypte, not only provided the foundations for modern day Egyptology but propelled the splendours of Ancient Egypt on to the world stage. The first Egyptian galleries opened at the Louvre in 1827 and it is during this period that the influence of Egyptian art and artefacts started to be seen in French design and décor. Egyptian-style jewellery became particularly popular during the 1860s, coinciding with the opening of the Suez Canal. The 1867 Exposition Universelle in Paris showcased the full extent of France's fascination and featured a reconstructed temple complete with sphinxes and a triumphal arc. Lavish creations by Parisian jewellers Boucheron and Lemonnier featured alongside more archaeologically-inspired pieces, such as those by Emile Froment Meurice and Eugène Fontenay. Across Europe the influence can be detected in the fine gold works of Alessandro Castellani, Carlo Giuliano, Ernesto Pierret and Giacinto Melillo, amongst others. In England, the visit of the Prince of Wales to Egypt in 1862 coincided with the display of antiquities from Cairo at The International Exhibition in London. Here, jewellers known to have worked in the Egyptian taste include John Brogden, Robert Phillips, E. W. Streeter and T. & J. Bragg of Birmingham.



Heinrich Taddel (or Dattel) (1715-1794) is recorded as a master goldsmith in Dresden from 1739, in which year he became Inspector at the Grünes Gewölbe (Green Vaults). Dresden, as a centre of production of precious snuffboxes, was unique in 18th century Europe in one respect, for its 'distinct and individual signature styles developed by some makers in the city,

... notably Neuber and Heinrich Taddel..." Taddel's workshops are credited with developing the technique of zellenmosaik, literally 'cell-mosaic', hardstone tesserae separated by strips of metal. Sheets of gold were pierced and filled with a marquetry of stones to form landscapes.

This box shows the transition and fusion of styles during the second half of the 18th century, where the decoration still harks back to the chinoiserie fashion of earlier decades.

- (d) to remove, store and insure the lot at the expense of the defaulting buyer and, in the case of storage, either at DNW's premises or elsewhere.
- (e) to charge interest at a rate not exceeding 2 percent per month on the 'total amount due' to the extent it remains unpaid for more than 5 working days after the day of the auction.
- (f) to retain that or any other lot sold to the same buyer at the sale or any other auction and release it only after payment of the 'total amount due'.
- (g) to reject or ignore any bids made by or on behalf of the defaulting buyer at any future auctions or obtaining a deposit before accepting any bids in future.
- (h) to apply any proceeds of sale then due or at any time thereafter becoming due to the defaulting buyer towards settlement of the 'total amount due' and to exercise a lien on any property of the defaulting buyer which is in DNW's possession for any purpose.

12 Liability of Dix Noonan Webb and sellers

- (a) Goods auctioned are usually of some age. All goods are sold with all faults and imperfections and errors of description. Illustrations in catalogues are for identification only. Buyers should satisfy themselves prior to the sale as to the condition of each lot and should exercise and rely on their own judgement as to whether the lot accords with its description. Subject to the obligations accepted by DNW under this Condition, none of the seller, DNW, its servants or agents is responsible for errors of descriptions or for the genuineness or authenticity of any lot. No warranty whatever is given by DNW, its servants or agents, or any seller to any buyer in respect of any lot and any express or implied conditions or warranties are hereby excluded.
- (b) Any lot which proves to be a 'deliberate forgery' may be returned by the buyer to DNW within 15 days of the date of the auction in the same condition in which it was at the time of the auction, accompanied by a statement of defects, the number of the lot, and the date of the auction at which it was purchased. If DNW is satisfied that the item is a 'deliberate forgery' and that the buyer has and is able to transfer a good and marketable title to the lot free from any third party claims, the sale will be set aside and any amount paid in respect of the lot will be refunded, provided that the buyer shall have no rights under this Condition if:
- (i) the description in the catalogue at the date of the sale was in accordance with the then generally accepted opinion of scholars and experts or fairly indicated that there was a conflict of such opinion; or
- (ii) the only method of establishing at the date of publication of the catalogue that the lot was a 'deliberate forgery' was by means of scientific processes not generally accepted for use until after publication of the catalogue or a process which was unreasonably expensive or impractical.
- (c) A buyer's claim under this Condition shall be limited to any amount paid in respect of the lot and shall not extend to any loss or damage suffered or expense incurred by him or her.
- (d) The benefit of the Condition shall not be assignable and shall rest solely and exclusively in the buyer who, for the purpose of this condition, shall be and only be the person to whom the original invoice is made out by DNW in respect of the lot sold.

Conditions mainly concerning Sellers and Consignors

13 Warranty of title and availability

The seller warrants to DNW and to the buyer that he or she is the true owner of the property or is properly authorised to sell the property by the true owner and is able to transfer good and marketable title to the property free from any third party claims. The seller will indemnify DNW, its servants and agents and the buyer against any loss or damage suffered by either in consequence of any breach on the part of the seller.

14 Reserves

The seller shall be entitled to place, prior to the first day of the auction, a reserve at or below the low estimate on any lot provided that the low estimate is more than £100. Such reserve being the minimum 'hammer price' at which that lot may be treated as sold. A reserve once placed by the seller shall not be changed without the consent of DNW. DNW may at their option sell at a 'hammer price' below the reserve but in any such cases the sale proceeds to which the seller is entitled shall be the same as they would have been had the sale been at the reserve. Where a reserve has been placed, only the auctioneer may bid on behalf of the seller.

15 Authority to deduct commission and expenses

The seller authorises DNW to deduct commission at the 'stated rate' and 'expenses' from the 'hammer price' and acknowledges DNW's right to retain the premium payable by the buyer.

16 Rescission of sale

If before DNW remit the 'sale proceeds' to the seller, the buyer makes a claim to rescind the sale that is appropriate and DNW is of the opinion that the claim is justified, DNW is authorised to rescind the sale and refund to the buyer any amount paid to DNW in respect of the lot.

17 Payment of sale proceeds

DNW shall remit the 'sale proceeds' to the seller not later than 35 days after the auction, but if by that date DNW has not received the 'total amount due' from the buyer then DNW will remit the sale proceeds within five working days after the date on which the 'total amount due' is received from the buyer. If credit terms have been agreed between DNW and the buyer, DNW shall remit to the seller the sale proceeds not later than 35 days after the auction unless otherwise agreed by the seller.

18 If the buyer fails to pay to DNW the 'total amount due' within 3 weeks after the auction, DNW will endeavour to notify the seller and take the seller's instructions as to the appropriate course of action and, so far as in DNW's opinion is practicable, will assist the seller to recover the 'total amount due' from the buyer. If circumstances do not permit DNW to take instructions from the seller, the seller authorises DNW at the seller's expense to agree special terms for payment of the 'total amount due', to remove, store and insure the lot sold, to settle claims made by or against the buyer on such terms as DNW shall in its absolute discretion think fit, to take such steps as are necessary to collect monies due by the buyer to the seller and if necessary to rescind the sale and refund money to the buyer if appropriate

19 If, notwithstanding that, the buyer fails to pay to DNW the 'total amount due' within three weeks after the auction and DNW remits the 'sale proceeds' to the seller, the ownership of the lot shall pass to DNW.

20 Charges for withdrawn lots

Where a seller cancels instructions for sale, DNW reserve the right to charge a fee of 15 per cent of DNW's then latest middle estimate of the auction price of the property withdrawn, together with Value Added Tax thereon if the seller is resident in the UK, and 'expenses' incurred in relation to the property.

21 Rights to photographs and illustrations

The seller gives DNW full and absolute right to photograph and illustrate any lot placed in its hands for sale and to use such photographs and illustrations and any photographs and illustrations provided by the seller at any time at its absolute discretion (whether or not in connection with the auction).

22 Unsold lots

Where any lot fails to sell, DNW shall notify the seller accordingly. The seller shall make arrangements either to reoffer the lot for sale or to collect the lot.

23 DNW reserve the right to charge commission up to one-half of the 'stated rates' calculated on the 'bought-in price' and in addition 'expenses' in respect of any unsold lots.

General Conditions and Definitions

- 24 DNW sells as agent for the seller (except where it is stated wholly or partly to own any lot as principal) and as such is not responsible for any default by seller or buyer.
- 25 Any representation or statement by DNW, in any catalogue as to authorship, attribution, genuineness, origin, date, age, provenance, condition or estimated selling price is a statement of opinion only. Every person interested should exercise and rely on his or her own judgement as to such matters and neither DNW nor its servants or agents are responsible for the correctness of such opinions.
- 26 Whilst the interests of prospective buyers are best served by attendance at the auction, DNW will, if so instructed, execute bids on their behalf. Neither DNW nor its servants or agents are responsible for any neglect or default in doing so or for failing to do so.
- 27 DNW shall have the right, at its discretion, to refuse admission to its premises or attendance at its auctions by any person.
- 28 DNW has absolute discretion without giving any reason to refuse any bid, to divide any lot, to combine any two or more lots, to withdraw any lot from the auction and in case of dispute to put up any lot for auction again.
- 29 (a) Any indemnity under these Conditions shall extend to all actions, proceedings costs, expenses, claims and demands whatever incurred or suffered by the person entitled to the benefit of the indemnity.
- (b) DNW declares itself to be a trustee for its relevant servants and agents of the benefit of every indemnity under these Conditions to the extent that such indemnity is expressed to be for the benefit of its servants and agents.
- 30 Any notice by DNW to a seller, consignor, prospective bidder or buyer may be given by first class mail or airmail and if so given shall be deemed to have been duly received by the addressee 48 hours after posting.
- 31 These Conditions shall be governed by and construed in accordance with English law. All transactions to which these Conditions apply and all matters connected therewith shall also be governed by English law. DNW hereby submits to the exclusive jurisdiction of the English courts and all other parties concerned hereby submit to the non-exclusive jurisdiction of the English courts.

32 In these Conditions:

- (a) 'catalogue' includes any advertisement, brochure, estimate, price list or other publication;
- (b) 'hammer price' means the price at which a lot is knocked down by the auctioneer to the buyer;
- (c) 'total amount due' means the 'hammer price' in respect of the lot sold together with any premium, Value Added Tax chargeable and additional charges and expenses due from a defaulting buyer in pounds sterling;
- (d) 'deliberate forgery' means an imitation made with the intention of deceiving as to authorship, origin, date, age, period, culture or source which is not shown to be such in the description in the catalogue and which at the date of the sale had a value materially less than it would have had if it had been in accordance with that description;
- (e) 'sale proceeds' means the net amount due to the seller being the 'hammer price' of the lot sold less commission at the 'stated rates' and 'expenses' and any other amounts due to DNW by the seller in whatever capacity and howsoever arising;
- (f) 'stated rate' means DNW's published rates of commission for the time and any Value Added Tax thereon;
- (g) 'expenses' in relation to the sale of any lot means DNW charges and expenses for insurance, illustrations, special advertising, packing and freight of that lot and any Value Added Tax thereon;
- (h) 'bought-in price' means 5 per cent more than the highest bid received below the reserve.

33 Vendors' commission of sales

A commission of 15 per cent is payable by the vendor on the hammer price on lots sold.
