

BILL TANKERSLEY (1948-2021)



Bill Tankersley was born April 10, 1948, in Columbia, Tennessee, USA. He was a collector at a young age, first interested in Native American arrowheads that he would find in newly plowed fields, and beautiful and unusual rocks and stamps. As a teenager, Bill became interested in antique collectibles and persuaded his parents to invest in them, too. Bill's parents are still living (ages 94 and 97) and have a house full of antiques thanks to their son.

After Bill was married in 1976, he realized his wife did not share his love of antiques and began his collection of coins which were small and easy to store. The couple began working with a church in South London, England in 1977, and Bill's focus became West Indian Countermarks as a reflection of his appreciation of that culture represented in so many of his church members. The years in England introduced Bill to Bob Lyall and to Baldwins who originally sold his collection at auction in 1998.

After returning to the states, Bill became interested in collecting other things such as Native American Art, after working for years with the Navajo in the American Southwest, but he kept coming back to coin collecting which he always loved. Sadly, Bill died August 19, 2021 with Covid-19. This sale represents his collection from 1998 to then. His family prays that the new owners of these coins and tokens will be blessed with enjoying the beauty, history, and culture that they represent as did their previous owner.

The so-called Anguilla Liberty Dollars were a self-initiated production by Scott Newhall, then editor of the San Francisco Chronicle. The island had split from the Associated State of St Kitts-Nevis-Anguilla and the new Anguilla provisional government declined to have these 'Liberty Dollars' recognised legally.

The British Colonial Hotel, formerly the New Colonial Hotel, which had opened in 1923, was acquired by Sir Henry Oake in 1934. Dirty Dick's, a hotel bar on Bay Street, Nassau, in the 1920's and 1930's, was later converted into a nightclub.

Cat Cay is a small island 15 miles south of Bimini. It was purchased by Louis Rice Wasey of New York in 1931. He developed the island into a private pleasure resort. The tokens were introduced in 1946 and valued at US \$1.00, 50 Cents, and 25 Cents; they were designed by Wasey's daughter Jane, and used for gaming and as souvenirs. XRF testing shows the correct metallic make up, which differs from the compositions given by Lyall.

Research by Professor Jerome Jambu, former curator of modern coins at the Bibliotheque Nationale in Paris, has uncovered the French documentation for this issue of cut countermarked coinage dating to October 1780. The Act specifies that the 8 Real coins would be cut into 11 segments. From a practical basis this would be virtually impossible and it is very likely the dollars were cut into 12 segments. Weights vary from one-tenth to one fourteenth of a dollar; the heavier segments being extremely rare as these would have been pulled out of circulation after legislation under British Administration in 1787 reducing the value of these cut pieces from 9 Pence to 6 Pence (*cf.* Pridmore, Appendix 31).

19 If the buyer fails to pay to Noonans the 'total amount due' within 35 days after the auction, Noonans will endeavour to notify the seller and take the seller's instructions as to the appropriate course of action and, so far as in Noonans' opinion is practicable, will assist the seller to recover the 'total amount due' from the buyer. If circumstances do not permit Noonans to take instructions from the seller, the seller authorises Noonans at the seller's expense to agree special terms for payment of the 'total amount due', to remove, store and insure the lot sold, to settle claims made by or against the buyer on such terms as Noonans shall in its absolute discretion think fit, to take such steps as are necessary to collect monies due by the buyer to the seller and if necessary to rescind the sale and refund money to the buyer if appropriate.
